Module 2	<p>2.2.7.</p> <p>As noted in the previous section, individual parts of monographic series generally have distinctive titles. Serials also, on occasion, have distinctive titles on some or all issues. Consult CCM 7.2.2f which provides more context and instruction for serial requirements.</p> <p>For monographic series, a library may choose to create a collective record instead of or in addition to creating records for the individual works in a series. When creating this collective record, consider following serial practice and create a note. Added entries for the individual titles are not generally given. The decision to add this note for collective records of monographic series is a matter of institutional policy.</p> <p>A replacement example will be: LCCN 2002033072 <u>The houses and collections of the Marquis de Marigny</u> (in series Documents for the history of collecting. Module 17	<p>17.7.3b</p> <p>Catalog separately as a serial, a reprint of a single serial. If the serial title has changed, create separate records for each title, even if the reprint consists of only one volume. Do not follow Original RDA 1.1 for title changes. Instead, follow LC-PCC PS for 1.11 principles for microform reproductions for using the original manifestation as the preferred source, for an example, see 17.7.6c. See also CEG Appendix L4 for a more comprehensive list of data elements and their relation to the original manifestation and/or reproduction.</p> <p>Catalog the reprint as a monograph, however, if it contains only a single issue or limited number of issues (Original RDA 1.5.3).</p> <p>17.7.4</p> <p>When describing a reproduction, record the data relating to the reproduction in the appropriate element (RDA 1.11). The opening paragraph from LC-PS 1.11:

The PCC follows an interim approach to cataloguing microform reproductions of print resources in the RDA environment. The general principle is to record descriptive elements for the print version, and give details of the microform reproductions, both those cloned from print version records and records created originally (i.e., no print record exists, or the cataloguer chooses not to clone from the print record).
